Automatic extensions for eligible visa holders until 31 December 2023

Executive summary

On 29 March 2023, the South African Department of Home Affairs (DHA) announced that holders of Long-Term Visas who submitted waiver or renewal applications and did not receive a decision regarding their application by 31 March 2023 received automatic extensions until 31 December 2023. This extension was enacted to mitigate the impact of current backlogs in visa application processing and issuance.

Key developments

Individuals who benefit from the automatic extension include holders of Long-Term Visas issued for the purpose of work, business, study or family reunification or to dependent spouses of primary applicants. These individuals may continue to conduct activities authorized under the terms of their current visa. They may depart from and re-enter South Africa prior to 31 December 2023 without facing penalties (e.g., being declared undesirable) even if their renewal application has not been adjudicated. In these cases, non-visa-exempt nationals (i.e., individuals who require a visa to enter South Africa on the basis of their nationality) must obtain a Visitor Visa to re-enter the country.

Holders of Short-Term Visas (i.e., with a validity of less than 90 days) who submitted renewal applications and did not receive a decision regarding their application by 31 March 2023 are not eligible for the automatic extension and must depart the country prior to the expiry of their existing visa.

Impact on employers

Employers may inform impacted employees of the temporary extensions to ensure compliance with immigration rules. In light of the backlog, employees may plan to submit renewal applications well in advance of their current Long-Term Visa's expiry to ensure they receive an extension on time and avoid non-compliance risks.
