New rules for extension of existing permits under the Temporary Protection Directive

Executive summary

The German federal government has passed additional rules regarding the Temporary Protection Directive (TPD) introduced due to the ongoing Ukraine crisis. Permits issued under the Temporary Protection scheme with an expiry date of 1 February 2024 or later will be automatically extended until 4 March 2025.

Background

Under the TPD, Ukrainian citizens and third-country nationals (i.e., nationals of countries outside the EU or EEA) who fled Ukraine may be eligible to receive various rights in an EU country that has adopted the TPD, including residence and work authorization, housing, and medical assistance. The TPD was initially in effect until 4 March 2023 and was then extended until 4 March 2024. In September 2023, the European Commission proposed extending the TPD further until 3 March 2025.

Key developments

Germany announced recently that effective 5 December 2023, a new rule has been added to the German implementation of the TPD. One aim is to mitigate potential delays in immigration application processing due to a large number of extension applications being filed in early 2024. Currently, more than 1 million people reside in Germany under the TPD.

Individuals holding a lawful TPD status as of 1 February 2024 will have their current permits automatically extended until 4 March 2025 and will not be required to obtain new permits until this date. These individuals will be able to reside and work in Germany until 4 March 2025 using their existing permits

even after their expiry. However, when traveling outside Germany, they must have one of the following documents:

- A valid physical permit (i.e., an updated official document such as a new Electronic Residence permit (eAT)
- An interim permit

Individuals who hold permits under the TPD that will expire before 1 February 2024 must file an extension application before their expiry.

Impact on employers

Employers may ensure that impacted individuals who hold permits under the TPD with an expiry date of 1 February 2024 or later remain fully compliant concerning residence and work authorization in Germany.
