Brazil reinstates visa requirement for nationals of Australia, Canada and the United States

Executive summary

On 10 April 2025, the Brazilian authorities <u>reinstated</u> the electronic visa (e-Visa) requirement for nationals of Australia, Canada and the United States who seek to travel to Brazil for business or tourism purposes.

Key developments

Effective immediately, impacted individuals are required to complete their application process <u>online</u>, as applications will not be accepted at consulates or embassies.

Impact on employers

Employers may ensure compliance with this new requirement and support impacted employees with potential costs associated with the e-Visa application.
