New salary requirements for certain foreign workers

#### **Executive summary**

Effective 29 August 2025, third-country nationals who apply for certain categories of work-based residence permits are subject to new salary requirements.

#### Key developments

Third-country nationals who submit the following categories of applications are now required to meet the minimum salary thresholds below:

- Talent Skilled Employee (Talent salarié qualifié): EUR 39,582 gross per year. Previously, the requirement was EUR 43,243 gross per year.
- Talent EU Blue Card (Talent Carte Bleue Européenne): EUR 59,373 gross per year. Previously, the requirement was EUR 53,835 gross per year.

### Impact on employers

Employers may consider the new salary thresholds when sponsoring third-country nationals for these permits to ensure compliance and mitigate business disruptions.
